 - Elected state wide as Land Commissioner in 2014 and took office January 1, 2015. Constitutional Office which manages 9,000,000 acres of surface and 13,000,000 million acres of mineral acres on behalf of New Mexico Schools. Produced \$739,000,000 in income for 2015. Brought business practices to state government and brought turnaround times on applications from 300 days down to 45 days.
