If elected, what would be your first priority as a City Councilor?

My top priorities are Public Safety, Expanding City Services, Affordable Housing, and an unwavering commitment to both environmental sustainability and cultural programs.

I think looking at some of our permitting laws and making them more streamlined, in particular around housing stocks for middle class families is a priority. We need to create enough housing for our workforce with as little red tape as possible. Other public works and city improvement projects could also benefit from a more streamlined and transparent permitting process.

Our state holds top national rankings for homicide and other serious crimes. How would you use the position of City Councilor to keep citizens safe?

We must address our critically understaffed city departments, first responders and law enforcement agencies. This means encouraging local recruitment and scouting for a broader range of skill sets which can reshape our local agencies. This will improve response rates as well as ensure appropriate response teams that can manage a wide range of crises. I am determined to improve the resources available to our first responders and reduce the overall costs and effect of crime in our community.

What would you do as a City Councilor to keep current businesses from closing/leaving while attracting more businesses to our Village/City/Town?

Santa Fe, along with the world, finds itself looking to an uncertain future. It is clear that business as usual is not working and we need new alternatives. New and creative business models offer a number of potential benefits for Santa Fe. By attracting and growing cooperatives, multi member LLC's and democratically run industries, the city can create a more sustainable, equitable, and prosperous economy for all. Small businesses are owned and operated by their members, who are typically local residents. This means that profits are reinvested in the community, rather than being sent to corporate shareholders elsewhere. Red Tape Reduction practices could greatly benefit non-traditional businesses and the communities they service.

think addressing "criminals" without ever tackling the root issues that promote criminal activity, is simply putting a bandaid on an open wound. As a city councilor, I would be aggressive at tackling the various causes of poverty that inevitably lead to low level property crime, while staffing and equipping our local law enforcement with the proper tools to address more violent crime.

Regarding the growing homeless situation, what is your plan as a City Councilor to address the needs of this population?

To address the rapid increase in unhoused members of our community, we must develop housing first models centered in areas where folks have ready access to all their needs in one central location. I will collaborate with city-wide organizations to ramp up their services and implement much needed health and wellness programming. We must help those most in need by addressing the current mental health and addiction crisis suffered by many of our unhoused. Finally, we must fully fund and staff our Alternative Response Unites.

I do support regulation on high caliber weapons, magazine restrictions, as well as wait times such as 24 hour cool down periods.
