Q8

If elected, what would be your first priority as a City Councilor?

Fight crime, which is inextricably, linked to fentanyl, addiction, homelessness and lack of behavioral health services. The plague of crime, fentanyl, addiction and homeless is everywhere. We need bold solutions. We can't sit idly while the city continues to decay and the plague we all see spreading around our neighborhoods gets closer to our families. Too many have suffered violence, break-ins and crime of every sort. Every city agency, law enforcement official and community group needs to work together with our state partners to end this plague.

My bold solution for addressing the plague of fentanyl, addiction and homelessness, is to bring to Albuquerque a Diversion Program used successfully in Miami-Dade County. It will address unmet needs and reduce recidivism. It is a one-stop shop for addiction and psychiatric services for unhoused people with acute mental illnesses who are in the criminal justice system or at risk of entering it. We cannot incarcerate our way out of mental illness or drug addiction. Drug addiction is responsible 80% of our crimes. Our system and jails are overloaded with people who are untreated. Our District Attorney, Public Defenders, and behavioral health court judges agree that a diversion program can is a method to reduce crime and homeless. We need all hands on deck.

I hear the victims and families clearly. We need change. Our families need to feel safer. Our streets need to be safer. I want 1600 officers and a stronger police presence in every community. We should support police and first responders with better pay. We need to comply with and end the DOJ consent decree. It's costing too much money and that money needs to be diverted to our community's problems not DoJs pocket. We need to close the "revolving door" in the court system and fix a broken criminal justice system by working with the NM Legislature.

As a small businesswoman, I will work tirelessly with every small business to reduce red tape at City Hall. I want to have a yearly workforce development conference for every large employer in Albuquerque and New Mexico so we can prepare our children for jobs that will pay them well and keep them here instead of leaving the state.

Q9

What can you as a City Councilor do to determine the usefulness of ordinances and regulations in serving citizens without unnecessarily overburdening anyone?

I think it is useful for business organizations and governments to stop every once and a while, look and see what is working and what is not working. As a City, we should do this. I also think it would be useful to hear from the community about what is working and what is not working specifically in their dealings with the City. I think it is good for Councilors to hear and to know this. I would support the City sponsoring town halls downtown across the City to collect information in this regard and then report to the Council with recommendations from the community of what needs to be done.

What would you do to streamline permitting and other government red tape in order to attract new business to the Village/City/Town?

We should hear from business that deals with City Government on a day-to-day basis and collect their observances about the problems they face. Once we know what the more specific issues are we should create a path forward to solve the problems. The City Government should be friendly and helpful to our local businesses. I would also like to look at what guidelines we have in place for all permitting. We need to be responsive to businesses who are applying for new or renewed permits. We should look at placing deadlines on permit approvals and if they are not approved by the deadline they are deemed approved. If our City Government is not responsive to business trying to live, grow and employ our citizens we are not doing our jobs.

Our state holds top national rankings for homicide and other serious crimes. How would you use the position of City Councilor to keep citizens safe?

Budget for and recruit 1600 officers. Support the Community Policing Councils. Comply with the consent decree with integrity. Fully staff APD. Bring in Bernalillo County Sheriffs to help. Get State Police involved. Get DEA and FBI to help. Implement a Diversion Program that will address unmet needs for the homelessness.

It is a one-stop shop for addiction and psychiatric services for unhoused people with acute mental illnesses who are in the criminal justice system or at risk of entering it. We have models that work in other cities; we just need to implement them.

Regarding the growing homeless situation, what is your plan as a City Councilor to address the needs of this population?

To implement a Diversion Program used successfully in Miami-Dade County. It will address unmet needs, reduce recidivism rate, and save us millions. It is a one-stop shop for addiction and psychiatric services for unhoused people with acute mental illnesses who are in the criminal justice system or at risk of entering it. Homelessness will not be eliminated, but must be managed by government. It is our moral responsibility to take care of the homeless. As a former state representative, I plan to advocate for pay for it with the 3.5 Billion surplus we will have next year. This will rebuild the addiction and behavioral health treatment system, rehabilitate the homeless population in a compassionate way, and focus on prevention. This will be a partnership with ACS, CABQ, Bernalillo County and Sheriff's Office, DA, Attorney General, and our State.

We have models that work in other cities; we just need to implement them. We cannot incarcerate our way out of mental illness or drug addiction. Drug addiction is responsible 80% of our crimes. Our system and jails are overloaded with people who are untreated. Our District Attorney, Public Defenders, and behavioral health court judges agree that a diversion program can is a method to reduce crime and homeless. Not everyone who is a drug addict is a criminal. This must be done with the help of our Federal and State Government.

Relating to 2nd Amendment rights, do you support or oppose ordinances or laws that would outlaw high-capacity magazines or 'assault rifle' possession? Please explain your answer.

I am a law-abiding gun owner. I have also held a conceal carry permit. Consideration of any law to restrict high-capacity magazines and assault rifles is an issue for the State Legislature to consider and decide. In Albuquerque, the City Council needs to fight crime by making sure our police department is fully funded, staffed and trained. We need to get control of fentanyl addiction and homelessness. We need to make sure we have adequate behavioral health services in place for those that need them. We have critical issues facing our community and we need to spend our time solving these problems and let the State Legislature take action on the issues that are properly a part of their statewide jurisdiction.
