Addiction And mental health are reoccurring issues, that have always been there, and it will always be there. The critical look at what is being done, where the money is being sent is overdue. A underappreciated aspect of crime in general is that for property, crime and some classes of violent crime, the vast majority of offenses are committed by a very small minority of the offenders. We need less police officers patrolling the street for traffic violations, and significantly more detectives and associated personnel tasked at actually catching the offenders early in their crime career. Early arrest and rehabilitation will pay long-term dividends in reduction in crime both now and in the future. But you have to arrest them before anything else can happen.
