As a trained educator, the state of our schools ranking from 50 down to 52, is the #1 priority. Every sector of the health of our state is affected, especially that of business. One of the 2011 School Board candidates ran because one of his employees couldn't differentiate between inches and centimeters. Clearly our schools are under performing. And it's not from lack of funding. APS's budget was \$2.1 Billion in 2023. This is with a decrease of about 20K students. It's not from lack of administrative positions. Our children are still suffering from the purposeful mismanagement of the Covid practices. Some may say - that is in the past, but just as one can see the damage in the rings of a tree from a severe drought, we will see the effects of the abuse of our children during this time. While we cannot go back, we can learn from what we experienced. New Mexico was the last state to re-open up. I believe that our children & our families need an apology from those who did this. Will we get one? Probably not. But hopefully parents will never allow this to happen again.

Many companies have created disaster relief plans in the event that some catastrophe happens. Their first order of business is to get rid of every extraneous activity. What is the goal of our schools? To educate, teach basic skills to give our children the basic tools to become a productive and successful citizen. Anything out of that scope needs to be eliminated. Focusing on ideologies that have a sliding scale of changing expectations does nothing except to waste precious time and mental energy of our children. In fact, as soon as one can master one area of that, it changes. Adding more hours or days to a child's education is not acceptable. They have families. They have goals. The goal of education should not be how NMPED should be able to trap a child into their indoctrination camps.

The second order of disaster recovery plans addresses the stake holders. Who are the stake holders? Well, there are actually 2 groups. The corporate drivers and the parents. Most of those participating are corporate representatives bringing proposals to get another slice of that \$2.1 Billion pie, using jargon that most parents and community members are not privy to even remotely understand.

I can't speak for other school districts, but since 2014, APS removed its public auditing requirements. Why? Their books should be under public scrutiny. Many, many questions need to be asked. But Parental participation is what will be needed to demand this change.
