In 1997 I was detained for a DUI allegation in Albuquerque. I took the case to court, and after three appearances before a judge, the case was summarily dismissed.

### Q9

What will be your #1 priority and what is your plan of action to address it, if elected?

We need to stop human, drug, and sex trafficking across our southern border. I recently visited Eagle Pass and Del Rio, Texas to see for myself, Operation Lonestar. I met with the Texas Border Czar, Michael Banks, who has formed a joint Task Force between the Texas Department of Safety (DPS) and the Texas Military Department to secure their border. They are currently building the wall, working with the local property owners, and meeting the federal requirements for the wall system. Prior to the building of the wall, they were encountering between 800-2000 illegal immigrants daily, that number is now down to less than 200 daily encounters.

They have evidence from the El Paso Customs and Border Patrol office to support the claim that the illegal immigration is now moving to New Mexico. Walls do work. NM needs to secure its border. Border security is public safety.

Other or comments::

New Mexico is not a poor state. I would like to see an Oil and Gas Annual Rebate returned to every NM citizen at the end of the calendar year based on the budget surplus similar to what Alaska gives to each of its citizens. Every New Mexican, regardless of age would receive \$100 for every \$1 billion in budget surplus the state receives in oil and gas revenue. For a family of four in 2023 with a \$3.5 Billion surplus they would have received \$350 each totaling \$1400 at the end of the year for the family. Given that there are roughly 2 million citizens in New Mexico, this would have reduced the budget surplus by \$700 million leaving \$2.8 Billion for reserves or other non-recurring investments. Every citizen should be able to share in the wealth of this state. The alternative is to eliminate individual income state taxes outright or reduce them to 1% leaving more money in the pockets of families where it belongs. In addition, I would like to eliminate state taxes on social security and military pensions for retirees to make NM a more retirement friendly locale.

Our tax system needs to be simplified to allow municipalities to charge a local tax rate commensurate with their local needs and eliminate the GRT tax code which is old and antiquated.

Q13 Crime has reached an all-time high in New Mexico. What do you think the state legislature could do to address ime?	Address mental health treatment., Pass legislation, similar to federal laws, with significant mandatory sentencing requirements for certain crimes and repeat offenders. , Address addictions and other lifestyles that impact criminal behavior. , Other or comments:: All of the above are essential if we are to address the crime issue holistically. First we must remove the homeless off the street and offer them mandatory counseling, drug rehabilitation, mental illness treatment, or face mandatory incarceration where they will get proper treatment and food. It is NOT compassionate to allow people to live homeless on the street and anyone who thinks or feels that way has never lived on the streets for any period of time. Vagrancy should be outlawed in the state of New Mexico.

New Mexico has passed laws that govern employeremployee relations such as increased minimum wage and paid time off among others. There have also been discussions about Paid Family Medical Leave Act (PFMLA), a living wage, and shortened work weeks. If elected, what position will you take on additional regulation of businesses on issues like those mentioned? I will not support additional government regulations on employer-employee relations.

Other or comments::

I think minimum wage should and will be eliminated. With the advent of Artificial Intelligence (AI) and the introduction of a future that includes humanoid robots replacing actual workers, the cost of labor will go down as robots can work 24/7, don't require medical insurance, or vacation benefits. Many mundane and repetitive jobs will be replaced and this will happen much faster than people are anticipating. Businesses will adapt, labor costs will go down, and productivity will increase exponentially and no amount of regulation will stop this trend.

I would also like to see a focus on growing technical and vocational programs for 9th - 12th grade to identify and support trade school students as well as college track students. Not everyone has to attend a 4 year institution.

Finally, Voter ID is critical to a safe and secure election. Identification is required for all matter of life's essentials: to purchase alcohol, to purchase a gun, to obtain medication, to fly on a commercial airliner, etc. One of the most important civic duties is to vote for your government representatives, and that duty should be protected. I will also advocate to utilize blockchain technology to ensure election integrity.
