**F = Anti-Business:** Favors expanded government control over individual rights and accountability.

**F\* = Unknown:** Candidate refused survey, hiding position from voters.

## SAMPLE BILLS USED FOR LEGISLATOR SCORES

Below are a few bills we used to grade legislators based on their voting records. If they supported a bill we opposed, they received negative points, and vice versa if they backed a bill we supported.

#### Paid Family Medical Leave Act-NMBC Opposed

Employers and employees would pay an amount into a fund, allowing the employee to take up to 12 weeks of paid time off. **HB6, HB11** 

#### **Organized Retail Crime- NMBC Supported**

Would give greater criminal charges to professional shoplifting, cargo theft, retail crime rings and other organized retail crime. **HB55** 

#### Minimum Wage Increase- NMBC Opposed

Legislators wanted to increase the minimum wage to \$16/hr and the wage of tipped workers starting on January 1, 2024. **HB25, HB28** 

#### **Enhanced Sentencing For Fentanyl- NMBC Supported**

Extra 3 years if more than 50 fentanyl pills; 5 years if more than 50 pills; and 7 years for more than 75 pills. **HB60** 

#### **Clean Fuel Standards- NMBC Opposed**

By 2030, decrease New Mexico's transportation fuel carbon intensity 20% from 2018 levels, aiming for a 30% reduction by 2040. **HB426, HB41** 

#### **Termination of States of Emergency- NMBC Supported**

State of Emergency orders will be terminated after 90 days, unless there's a special legislative session to address the issue. **HB218, HJR3** 

#### Low Income Public Utility Rates- NMBC Opposed

Extra fees on utility bills would cover low-income family rates based on income brackets to determine who pays and benefits. **HB218** 

#### 25% GRT Deduction For Small Businesses- NMBC Supported

Small businesses with 4 or less full and/or part-time employees would receive a 25% Gross Receipts Tax (GRT) deduction. **HB163**
