My top priority is crime. I will work to repeal the bad legislation passed in recent year which make it difficult to arrest, hold, prosecute, and incarcerate criminals. A few examples among many are; the Case Management Order which leads to dismissals of quite heinous crimes on minor technicalities, the "get of jail free" bail laws, The 2023 HB4 law which extends voting rights of convicted felons, and the use of "sanctuary city" status (condoned and encouraged by the state) to hamstring federal law enforcement. These measures, combined with demonizing the police, have hindered law enforcement, and led to skyrocketing crime rates. Not one of the above policies was meant to reduce crime or protect law abiding New Mexico citizens. Passing these laws demonstrates rank legislative negligence. To be fair the city of Albuquerque was complicit as well. I will work to overhaul the criminal justice system by repealing every pro-criminal, anti-police law on the books and then pass reasonable common-sense legislation focused on the safety of law-abiding citizens.

This provision is just one of many pro-criminal, anti-police laws that have turbo charged crime in our state.
