Other or comments::

The imposition of additional taxes on commerce hurts everyone. Businesses and consumers face higher costs of goods and services. Taxes are imposed on transactions, not profits, and are an imaginary excuse to impose real taxes. This makes doing business in New Mexico more expensive, penalizing any industry considering this location. For New Mexicans, this restricts employment opportunities and industry. Other or comments::

Our bail system is the opposite of what worked in the past. A special hearing and justification is required to establish bail or a hold. Previously, all were held unless bail could be justified. If a speedy trial could be afforded, there would be no need for "catch and release." The approach is wrong and hurts New Mexico. If you live here, own a home, work here and can reasonably be expected to appear/answer the charges, with none or trivial offenses, release is appropriate. If it's a serious crime where you might flee/avoid prosecution, you have charges or convictions previously, you don't have a residence, a job, family or some reasonable attachment to New Mexico, release from custody is equivocal with release from accountability.

# Address mental health treatment.,

#### Other or comments::

Crime is at an all-time high, due to pro-criminal, pro-drug policies and administrations that shun accountability. All the above suggestions sound reasonable, but none of them will work until accountability is established. Police must be held to a higher standard. They must be expected to respond and intervene in criminal actions. None of the proposed actions can occur without police intervention. The legislature can pass laws to get the desired result from the judiciary to resolve but an arrest is required for a judge to preside. The arrest leads to a hearing and fines, imprisonment, treatment or some combination of results. We need to support the police with funding and qualified immunity. We must also establish police accountability at all levels.

#### Other or comments::

As a policy, I view it as a contract with the government. If incentives are provided under contractual conditions, we should be able to pursue a remedy if those conditions are not met. The language of such awards must be clear, and prejudicial to the state...making it easier to enforce legally. There are a variety of incentives and enforcement options available. The options must be clearly articulated in writing upon award, in a way that effectively enforces the award conditions. The same would be expected from any contract you enter into as an individual or business.
