Economic development: Albuquerque business owners have reported that getting permits can take 6 months or longer, and needless 'red tape' stifles efforts to open or expand. What will you do to speed up business permits and other business requirements to encourage economic development, business expansion, and new businesses?

I'd like to highlight a significant issue that perfectly illustrates the need for change within Albuquerque's permit process. Both Dutch Brothers Coffee's Albuquerque and Rio Rancho construction permits were submitted on the exact same day. However, the stark difference in outcomes speaks volumes about the efficiency of our systems. Rio Rancho's facility was operational and serving the community within the same year, while Albuquerque's permit process lagged, leaving the project incomplete and stalled. This discrepancy is a clear indicator of the urgent need for reform in our city's permitting procedures. Such delays are not conducive to business growth or economic development in Albuquerque. It's imperative that we address and rectify these inefficiencies to foster a more business-friendly environment that encourages growth and prosperity.

The Code of Enforcement division and the Planning Department will undergo a comprehensive reorganization from top to bottom. This initiative will involve city employee advisors, including the mayor, contractors of all sizes, and both large and small developers. The restructured organization will prioritize fast-track permitting and planning processes. Currently, Albuquerque is facing a stagnation in economic growth, and this reorganization aims to catalyze development. The end goal is to create a system that is both user-friendly and efficient. We are committed to ensuring that all phone inquiries are met with a live response, and upon visiting our offices, individuals will be personally greeted and guided, rather than being directed to a website. Having owned a family business for 23 years, I deeply understand the challenges and frustrations of navigating city processes. What is your plan to deal with illegal encampments in the city?

To tackle the challenge of illegal encampments in our city, we are adopting a detailed and humane strategy that emphasizes safety and resolution. Our approach includes the deployment of armed private security personnel who will patrol on foot in areas where the homeless are primarily located. These security officers will be outfitted with body cameras, ensuring that all interactions are conducted with transparency and accountability. The initial step for these officers is to engage with the homeless community, aiming to understand each individual's circumstances and identity. After this engagement phase, the city will proceed to determine the origins of these individuals. Following the collection of this information, we will issue citations for any violations encountered. These citations will then be forwarded to local judges for adjudication. Should a homeless individual be found guilty of a violation and fail to appear in court, a warrant for their arrest will be issued. At this juncture, the individual will be presented with a choice: face jail time or leave the city. For those who opt to leave, we will provide complimentary bus tickets to their hometowns. This policy is crafted to address the pressing issue of illegal encampments while also offering a means for those impacted to reconnect with their communities and access additional support.

Crime: Albuquerque is in a crime crisis, and is one of the most dangerous cities of its size in the U.S. Please answer the following: How would you empower the Albuquerque police force to better address this situation?

To effectively combat the crime crisis in Albuquerque, which ranks as one of the most perilous cities of its size in the U.S., I propose a comprehensive crime prevention strategy that includes immediate and strategic actions:

1. Implement a strict curfew for individuals under the age of 18, with certain exceptions, prohibiting them from being outdoors after 11:00 PM. This measure addresses the alarming trend of minors, including those as young as 11 to 14 years old, being involved in violent crimes.

2. Undertake a complete overhaul of the Albuquerque Police Department (APD) from top to bottom, ensuring that our police force is more efficient, responsive, and equipped to handle the complexities of modern policing.

3. Introduce a Police ROTC program within our schools to foster a sense of civic duty and law enforcement career interest among students. This program will serve as a pipeline for young individuals to engage positively with their community and consider careers in law enforcement.

Launch a "Police Day Work" initiative, which will assemble a team of retired law enforcement professionals from various agencies, including the APD, Sheriff's Department, State Police, FBI, CIA, and Federal Marshals. These seasoned officers will patrol the streets, offering their expertise and visibility to deter crime. Importantly, these officers will serve as contractors, not city employees, which has already garnered positive feedback from the retired law enforcement community.

Through these measures, we aim to declare and effectively wage a war on crime, prioritizing the safety and security of Albuquerque's residents and visitors.
