### HOW NMBC GRADED CANDIDATES:

**A= Job Creator:** Supports public safety, better education & job creation via healthy business opportunities.

**F= Government Promoter:** Supports fewer criminal limits, fewer job options, more educational red tape, higher taxes.

**F\*= Unknown:** The candidate did not fill out NMBC's candidate survey, depriving voters of knowing their position on major issues.

# BADBILS VESIOPED

These bills listed are some of those we stood against as they would've hurt New Mexican families and business owners. The voting records of these bills were used for legislator's grades.

A ARIA

#### **Paid Family Medical Leave Act**

Employers and employees would pay an amount into a fund, allowing the employee to take up to 12 weeks of paid time off. **HB6, HB11** 

#### Minimum Wage Increase

Legislators wanted to increase the minimum wage to \$16/hr and the wage of tipped workers starting on January 1, 2024. **HB25, HB28** 

#### **Clean Fuel Standards**

Reduces the carbon intensity of fuels (like gasoline) that are used for transportation in New Mexico by at least 20% compared to 2018 levels by 2030 and 30% by 2040. **HB426, HB41** 

#### Low Income Public Utility Rates

Extra fees would be added to utility bills, to cover the rates of lowincome families, determined by income brackets to see who pays and who benefits. **HB218**

#### **Organized Retail Crime**

Would give greater criminal charges to professional shoplifting, cargo theft, retail crime rings and other organized retail crime. **HB55** 

#### **Enhanced Sentencing For Fentanyl**

Extra 3 years if more than 50 fentanyl pills; 5 years if more than 50 pills; and 7 years for more than 75 pills. **HB60** 

#### Termination of States of Emergency

State of Emergency orders will be terminated after 90 days, unless there's a special legislative session to address the issue. **HB218, HJR3** 

#### **25% GRT Deduction For Small Businesses**

Small businesses with 4 or less full and/or part-time employees would receive a 25% Gross Receipts Tax (GRT) deduction. **HB163** 



NMBC watched these bills closely, to see if they could pose any threat to our members and these bills did not. These are a few bills we closely monitored during their committee hearings.

#### Legislative Session Changes, Ca

Changes the length of Legislative Sessions. Instead of sessions being 30 days every other year, it would be 60 or 45 days yearly. HJR2, HJR14

#### **Prohibit Modified Mufflers**

The state fiscal budget could not continue to increase year after year and would be capped at a certain amount. **HB71** 

#### **Use Of Auto Traffic Enforcement Systems**

Authorizes the use of Auto Traffic Enforcement Systems to issue certain violations. **HB22**
