HOW WE GRADED NM SENATORS:

A = Pro-Business: Favors individual freedom, accountability, and less government control.

F = Anti-Business: Favors expanded government control over individual rights and accountability.

F* = Unknown: Candidate refused survey, hiding position from voters.

SAMPLE BILLS USED FOR LEGISLATOR SCORES

Below are a few bills we used to grade legislators based on their voting records. If they supported a bill we opposed, they received negative points, and vice versa if they backed a bill we supported.

Paid Family Medical Leave Act- NMBC Opposed

Employers and employees would pay an amount into a fund, allowing the employee to take up to 12 weeks of paid time off. **SB11, SB3**

Cap Growth Of State Budget- NMBC Supported

The state fiscal budget could not continue to increase year after year and would be capped at a certain amount. **\$B486**

New Home Build Renewable Requirements- NMBC Opposed Newly built residential homes would require solar panels to provide at least one watt per sq. ft of heated area and a charging station. SB77

Additional 2021 Income Tax Rebates- NMBC Supported

Those who filed in 2021 would get \$700, if filed single, and \$1400, if filed as a married couple. **SB10**

Flat Corporate Income Tax Rate- NMBC Opposed

Creates a flat corporate income tax rate, regardless of size, revenue, and other factors. **SB189**

Certain Drug Possession & Habitual Offender- NMBC Supported Simple drug possession would not be used to increase sentences for

those who are already convicted felons. SB187

Housing & Rent Changes- NMBC Opposed

Affordable rentals would be less available by passing risks onto tenants, causing some landlords to sell their units. **SB411, SB186**
